# New Items Added to the Newsletter that are Important

#### **Parent Library Controls**

Our library circulation system provides the option for parents to restrict access to specific titles in circulation in our school library, if you choose that option for your child. While the school shall make reasonable efforts to ensure that the student is not provided with access to such materials, it is the responsibility of the parent/guardian to ensure that the student understands the restriction and does not attempt to access the materials. If you are interested in restricting specific library titles for your student(s), please visit the "Parent Library Controls" webpage for more information.

Restriction of library materials using the "Additional User Type" is a parent's responsibility. Librarians and school administrators can provide access to the link but cannot provide support within the system.

#### **News from the Clinic**

Medication cannot be administered to any student without appropriate authorization forms completed and on file. Any medication must be provided in a new, sealed container with the completed authorization form. Students may not transport medication to and from school. Any medication not meeting the PWCS regulations will not be administered to your student.

It is highly recommended that students with chronic health conditions such as Asthma and/or food allergies have an emergency action plan and medication at school. Please head to the clinic website at <a href="https://occoquanes.pwcs.edu/about\_us/nurse\_clinic/forms">https://occoquanes.pwcs.edu/about\_us/nurse\_clinic/forms</a> to find forms applicable to your child's needs. Plans must be completed by your child's physician. Medication accompanying the forms must be brand new, not expired and match your child's name and prescriber information.

All kindergarten and 3rd grade students will have their hearing and vision screening completed starting the week of September 16th. Parents will be notified in writing for those students who do

The Virginia Department of Education (VDOE) released the annual Virginia Standards of Learning (SOL) test results and updated the <u>School Quality Profile</u>. We are well on our way to fully recovering from the pandemic. Occoquan has scored some of the highest scores in Reading and Math. Our African-American scores are what I am most proud of, as we have now surpassed the achievement gap in this category. PWCS will work diligently to support continued academic progress, acceleration, and recovery.






